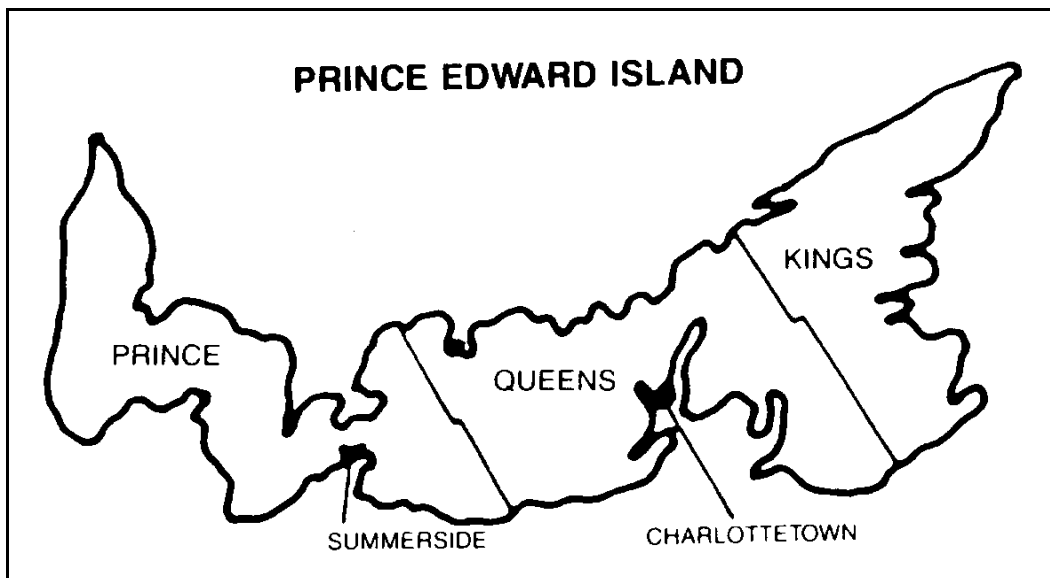

# ECONOMIC REVIEW 2000

## OVERVIEW

The Prince Edward Island economy performed well in 2000. Estimates of economic growth, as measured by constant dollar *Gross Domestic Product* (GDP), indicate that the provincial economy expanded by 2.9 per cent,<sup>(1)</sup> which compares to a national rate of 4.7 per cent. Economic expansion in 2000 reflected increased employment, rising personal incomes and improved export performance. This is the third year of economic growth in the order of 3 per cent on Prince Edward Island.

The leading growth sectors in the province were: services to business, retail trade and manufacturing. By contrast, the agricultural sector experienced some economic difficulty as a result of low potato prices and a ban on potato exports to the United States.

Consumer prices were on the rise in 2000 as the price of international crude oil increased steadily. The average annual increase in the national *All-Items Consumer Price Index* (CPI) was 2.7 per cent. This compares with an average consumer price index increase for Prince Edward Island of 4.1 per cent. The difference between the national and provincial rates is the result of the larger dependency on oil on Prince Edward Island.

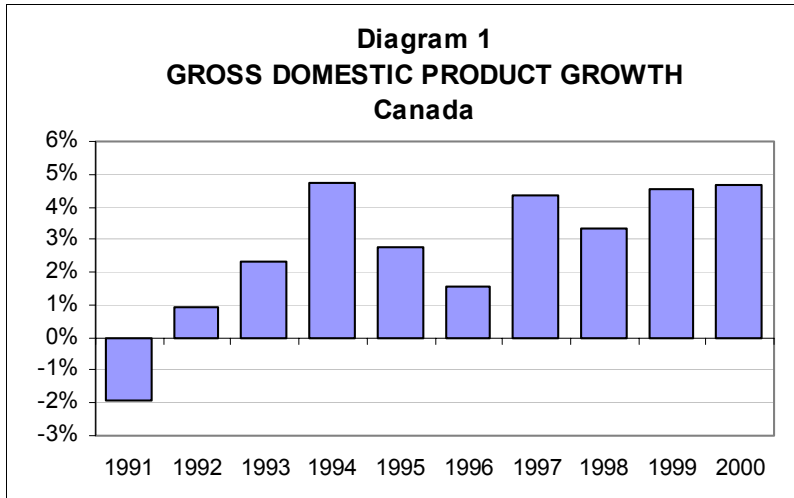
Island employment grew by 5.2 per cent during 2000, easily the fastest rate in the country. Total employment averaged 64,500 people and the unemployment rate dropped from 14.4 per cent in 1999 to 12 per cent in 2000. These vigorous employment gains translated into equally strong total labour income growth of 8.6 per cent during 2000.

The value of manufacturing shipments expanded by 6.6 per cent, totalling \$1,183 million. Food shipments increased by 10.8 per cent, while shipments of transportation and equipment were off by 24.2 per cent in 2000. The economic performance of Prince Edward Island is discussed in further detail after a brief consideration of the national economy in 2000.

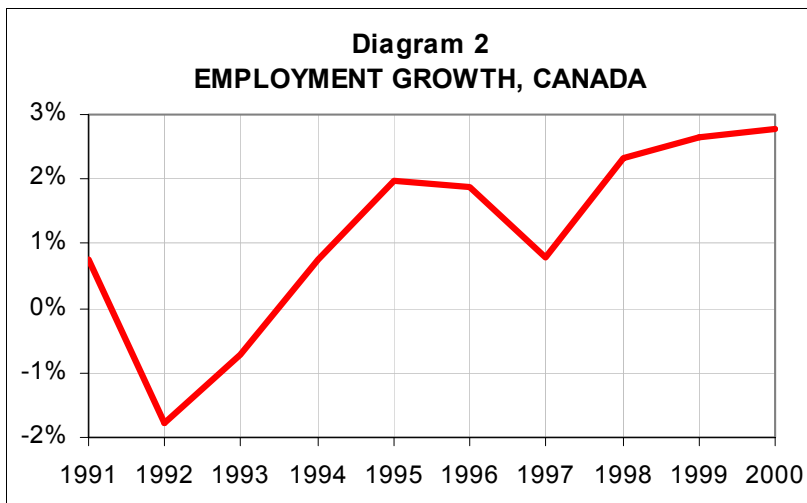

the United States, among the Group of Seven (G-7) leading industrialized nations. The 2000 expansion, measured in constant dollars, was the highest since 1994 and was led by gross fixed capital formation (up 11.2 per cent), followed by exports of goods and services (up 9.6 per cent), and consumer spending (up 4.4 per cent). Government spending was up 2.4 per cent in 2000, and the Government of Canada for the fifth consecutive year recorded a surplus of revenue over spending and debt servicing.

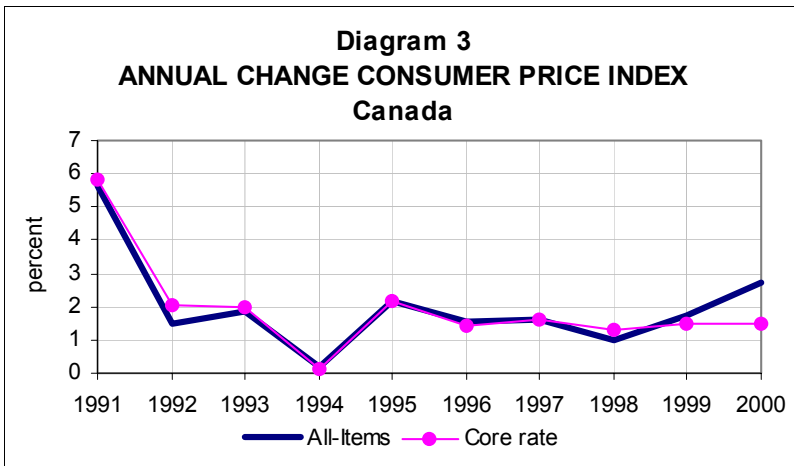

The Canadian economy ended the millennium with an upsurge in economic performance. It posted real GDP growth of 4.7 per cent in 2000, thus continuing the growth trend that started in 1992 (see Diagram 1). On an international scale, the robust rate of expansion placed Canada in second place, after

As Diagram 2 illustrates, 2000 marked the fourth consecutive year of strong employment growth, with 378,500 new jobs created during the year. Canada's unemployment rate averaged 6.8 per cent during 2000, its lowest rate in more than twenty-five years.

Most job creation occurred in the following sectors: management, administrative and other support services (up 7.6 per cent); health and social services (up 5.7 per cent); construction industry (up 5.4 per cent); and transportation and warehousing services (up 4.9 per cent). Employment decreased in agriculture (down 8.6 per cent), public administration (down 1.6 per cent), and educational services (down 0.7 per cent).

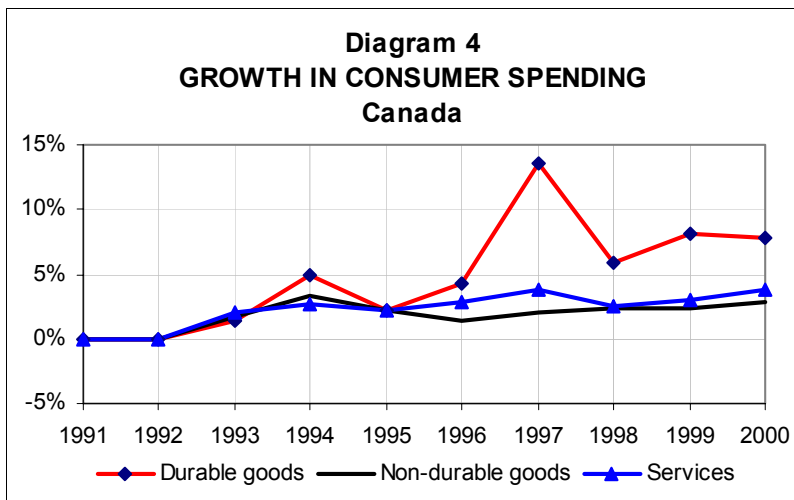

The inflation trend of the past decade demonstrates the significantly lower rate of price increases in Canada since 1991.

The headline inflation rate in Canada averaged 2.7 per cent in 2000, 1 percentage point higher than a year ago. This increase was mainly the result of rising energy costs. As Diagram 3 illustrates, the core inflation rate, i.e. the *All-Items Index* with the effects of energy and food prices removed, was virtually the same as in 1999 at 1.5 per cent.

The *3-Months Treasury Bill* interest rate averaged 5.4 per cent in 2000, 0.8 percentage point higher than in 1999 and the highest rate since 1995. Peaking in May 2000 at 5.7 per cent, the rate fluctuated between 5.6 and 5.5 per cent during the rest of the year.

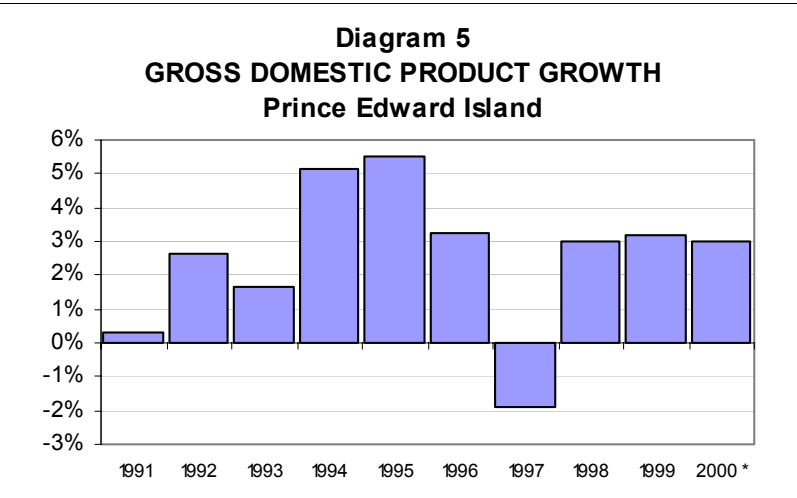
Diagram 4 illustrates constant dollar growth in consumer spending during the last ten years. As can be seen, consumer spending on durable consumer goods, such as automobiles and appliances, is more variable than expenditures on non-durables and services.

In 2000, overall consumer spending in constant dollars was up by 4.4 per cent. Personal expenditure on durables increased by 7.8 per cent, while spending on non-durable goods and services was up by 2.1 per cent and 3.7 per cent, respectively. Consumer spending in 2000 measured in current dollars totalled \$591 million, up 5.8 per cent from 1999.

Retail sales in current dollars in Canada rose 6.2 per cent to value \$277 billion, while sales of new motor vehicles increased 3.5 per cent to total \$46.9 billion. Manufacturing shipments increased by 9.2 per cent in 2000 compared to 1999, led by chemical products, fabricated metal products, and machinery. Canadian exports in 2000, valued at \$388.8 billion and up 16.3 per cent from 1999, were a prime driving force for the economy. The number of national housing starts was up slightly in 2000, from 150,000 units in 1999 to 152,000 in 2000.

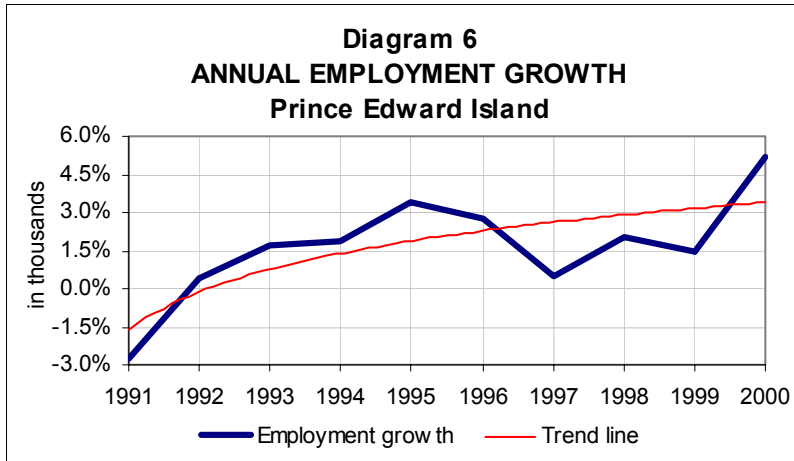

The latest statistics on the economy suggest that Prince Edward Island’s GDP was \$3.2 billion in 2000, an increase of 2.9 per cent over 1999 in real terms. Economic expansion in 2000 reflected increased employment, rising personal incomes and improved export performance.

Sectors which are estimated to have contributed the most to GDP growth were: services to business, retail trade and manufacturing. Diagram 5 shows annual growth rates for the provincial economy between 1991 and 2000, which, on average, were 2.6 per cent. This compares to an average national rate of growth of 2.7 per cent during the same period.



## EMPLOYMENT

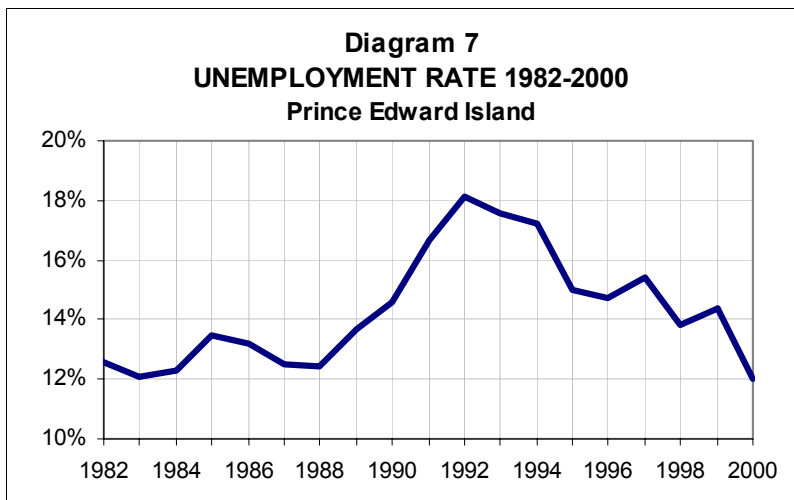

Prince Edward Island led the nation in employment growth during 2000. Employment increased from 61,300 in 1999 to a record level of 64,500 in 2000, an increase of 5.2 per cent. Diagram 6 shows the upward trend in Island employment from 1991 to 2000.

During the period 1991-2000, employment grew by 21 per cent, while the Island population grew by 6.6 per cent and the labour force increased by 14.5 per cent. Thus, job growth outpaced both population and labour force growth.

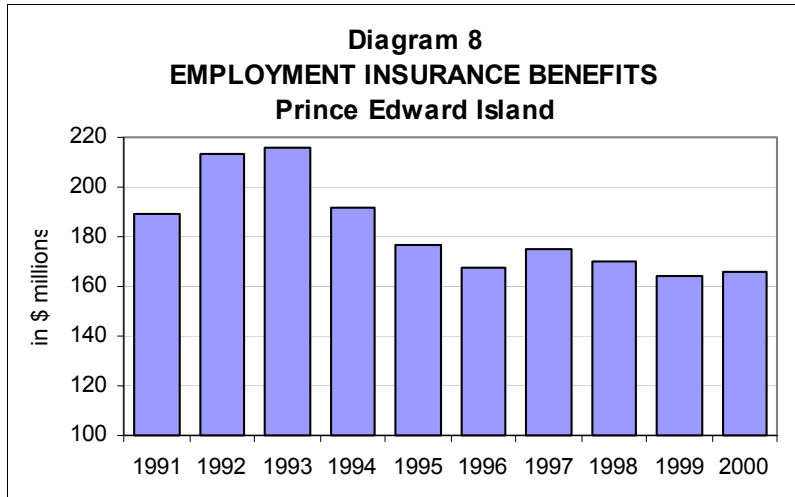

The provincial unemployment rate averaged 12 per cent in 2000, 2.4 percentage points lower than in 1999. This is the lowest rate since 1983 (see Diagram 7). The number of unemployed persons declined by 15 per cent, from 10,300 persons in 1999 to 8,800 in 2000. This drop was a result of buoyant economic conditions

The workforce, as measured by the participation rate, reached a record high of 66.9 per cent in 2000. This compares to a national rate of 65.9 per cent that year.

## INCOME

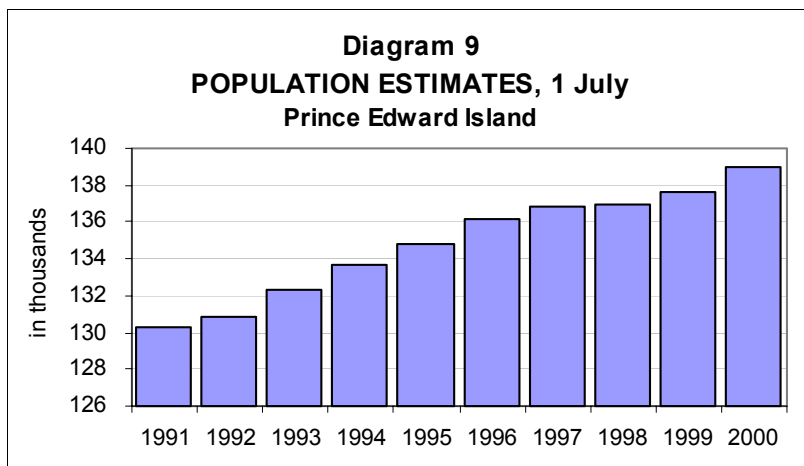
Total personal income for Prince Edward Islanders increased from \$2.8 billion in 1999 to \$2.9 billion in 2000, an increase of 5.1 per cent. The major contributor to this growth was labour income, resulting from the buoyant economy. By contrast, government transfers to persons were not a significant growth factor.

Employment Insurance (EI) be-nefits made up 52 per cent of all federal transfer payments to persons in the province in 1991. By 1998 this share had dropped to 42 per cent. The total value of EI benefits was virtually unchanged in 2000 at \$165 million. As Diagram 8 indicates, total benefits have dropped 23 per cent since 1993, when payments reached \$216 million. The average weekly benefit payment was \$286.43, 2.3 per cent higher than a year ago.

## POPULATION

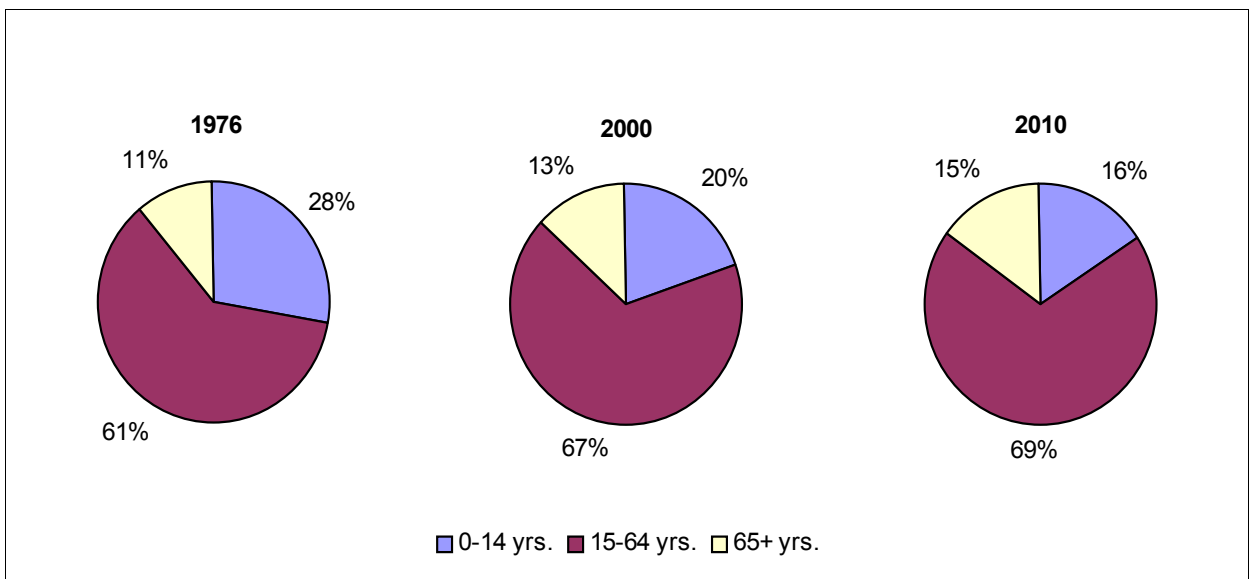

On 1 July 2000, the Island population reached 138,928, an increase of 0.9 per cent over 1999. The last decade has seen a 6.6 per cent increase in population, which compares to a national rate of growth of 9.7 per cent. Diagram 9 displays population levels for Prince Edward Island from 1991 to 2000.

The Island's ten-year growth rate compares well with those in the other Atlantic provinces. Between 1991 and 2000, the populations of Nova Scotia and New Brunswick increased by 2.8 per cent and 1.5 per cent, respectively, while Newfoundland experienced a decline of 7 per cent.

Diagram 10 illustrates the change in population distribution for Prince Edward Island in 1976 and 2000 and the Provincial Treasury projected distribution for 2010. In 1976, 28 per cent of the population was between 0 and 14 years of age. In 2000 this group's share had dropped to 20 per cent, while, according to the Provincial Treasury projection, this age group will further



decline to 16 per cent in 2010.

**P.E.I. POPULATION DISTRIBUTION**

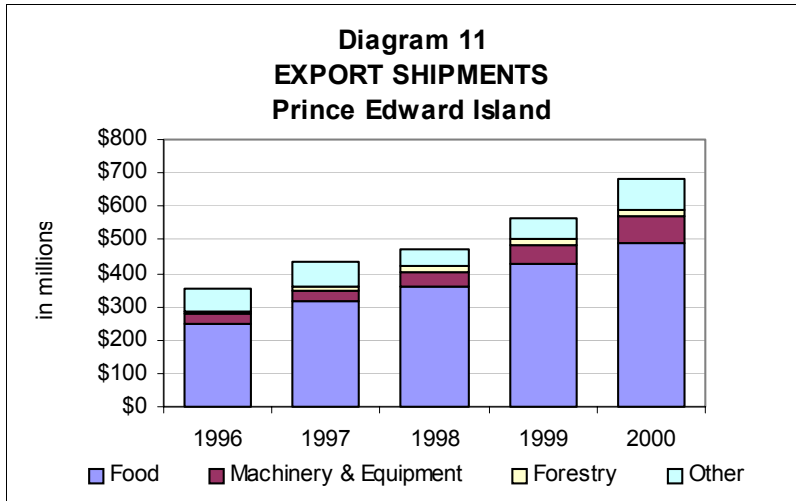
The age group 15 to 64 years made up 61 per cent of the Island population in 1976. Twenty-five years later the share of this group had risen to 67 per cent. It is expected to increase further to 69 per cent in 2010.

The senior population of Prince Edward Island, those individuals 65 years and older, made up 11 per cent of the 1976 population. In 2000, this age group had risen to 13 per cent and is projected to increase to 15 per cent in 2010.

# INDUSTRIAL PROFILES

## EXPORTS

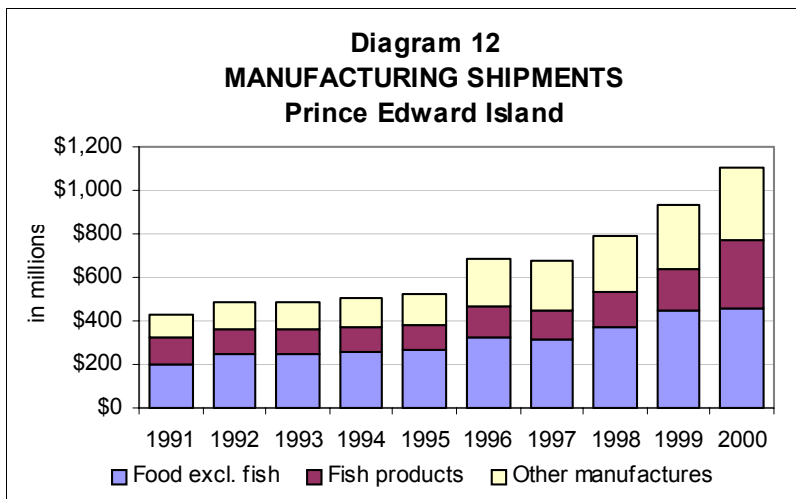

In 2000, the value of export of goods from Prince Edward Island to other countries rose by 20 per cent to a total value of \$679.4 million. This included \$491.3 million in food products, \$80.6 million in machinery and equipment, and \$16.3 million in forestry products. As is evident in Diagram 11, food products continue to play an important role in exports.

## MANUFACTURING

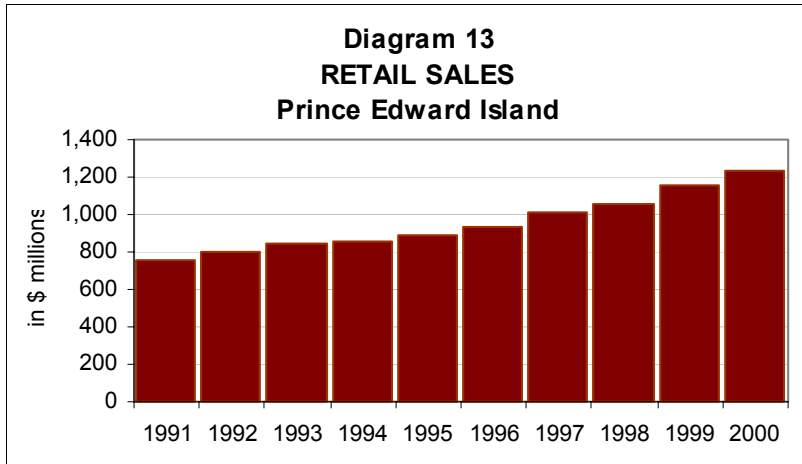
It is estimated that Prince Edward Island's manufacturing sector in 2000 accounted for 10 per cent of provincial GDP. On average, 6,500 persons were employed in this sector, which was 51 per cent higher than the number of manufacturing jobs recorded in 1992.

The province's manufacturing shipments were valued at \$1.2 billion in 2000, 6.7 per cent higher than in 1999. As Diagram 12 indicates, food and fish products continued to play a significant role in the manufacturing sector in 2000. Together they accounted for 72 per cent of total shipments and were valued at \$854 million, an increase of 11 per cent from 1999.

## RETAIL TRADE



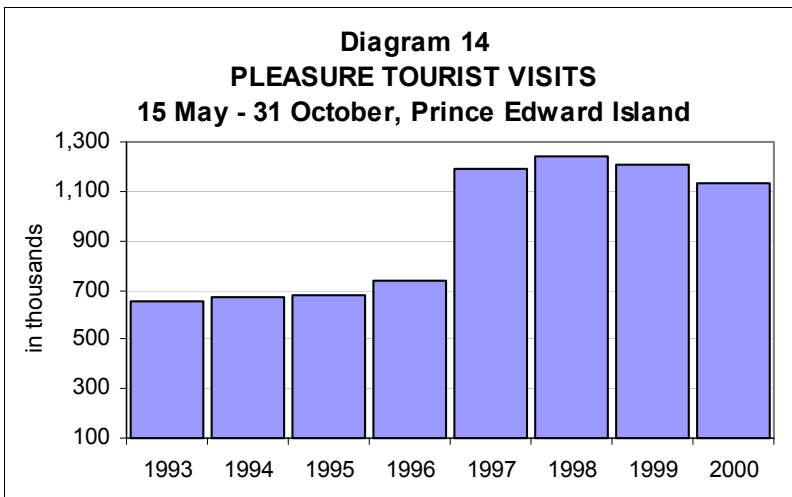

Provincial retail sales have steadily increased since 1991, as is evident from Diagram 13, which displays annual sales. In 2000 over \$1.23 billion worth of goods were sold, an increase of 6.4 per cent from 1999. Department store sales amounted to \$373 million, while sales of new automobiles and com-

mercial vehicles totalled \$58 million and \$69 million, respectively. The wholesale/retail trade sector continues to be the largest private sector employer in the province with 9,900 people employed in 2000. Since 1992 employment in this sector has grown by more than 25 per cent.

## TOURISM

Prince Edward Island continues to be a premier tourist destination attracting a large number of visitors. As Diagram 14 indicates, the number of pleasure tourists who visited the Island since the opening of the Confederation Bridge in 1997 has greatly increased. However, the number of

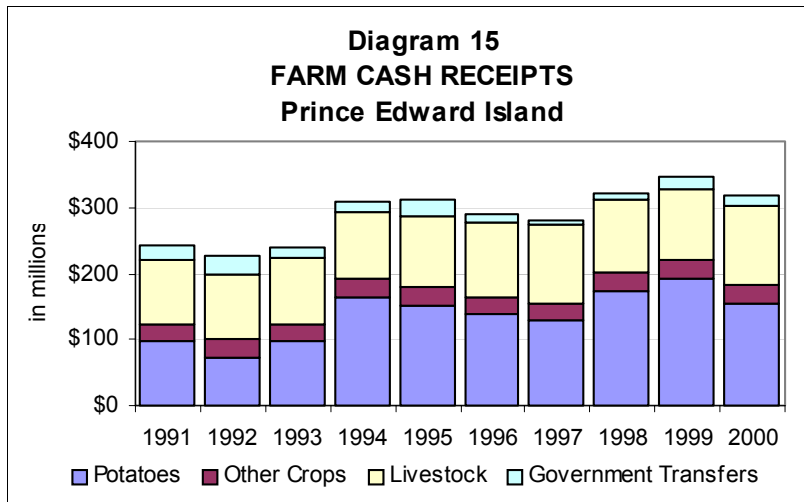

pleasure tourists visiting Prince Edward Island in 2000 was off by 7.1 per cent from 1999. This was mainly due to inclement weather, high gasoline prices, and competing tourist events in neighbouring provinces, such as the Tall Ships celebration in Nova Scotia. Total tourist expenditures in 2000 of \$301 million were on par with 1999.

Canadians accounted for 70 per cent of all visits to Prince Edward Island, while 28 per cent of visits originated in the United States. During the 2000 tourist season, 24 per cent of all visitors came from Ontario, 17 per cent from Nova Scotia, and 11 per cent from New Brunswick. The number of visitors from the United States was 77 per cent higher in 2000 than in 1999.

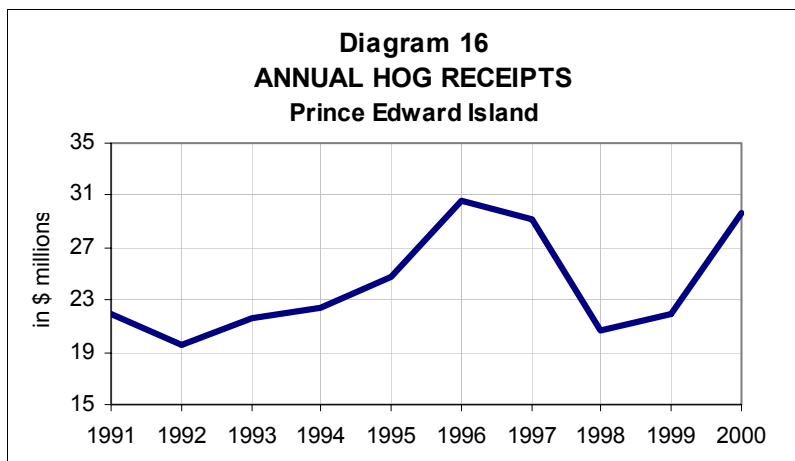
## AGRICULTURE

As Diagram 15 illustrates, potato receipts were the most variable component of farm cash receipts during the last ten years. In 2000, potato receipts declined by 19 per cent due to lower prices and, during the latter part of the year, a ban on potato imports to the United States. This decline caused a 8.3 per cent drop in total farm cash receipts, from \$347 million in 1999 to \$318 million in 2000. Other farm produce prices fared better in 2000: livestock receipts reached an all-time high of \$117.3 million, 10 per cent higher than last year, while dairy receipts increased by 4.1 per cent to \$51 million. Cattle receipts reached \$25.6 million, up by 3.2 per cent, although, on a volume basis, beef slaughtering was down by 7 per cent over 1999.

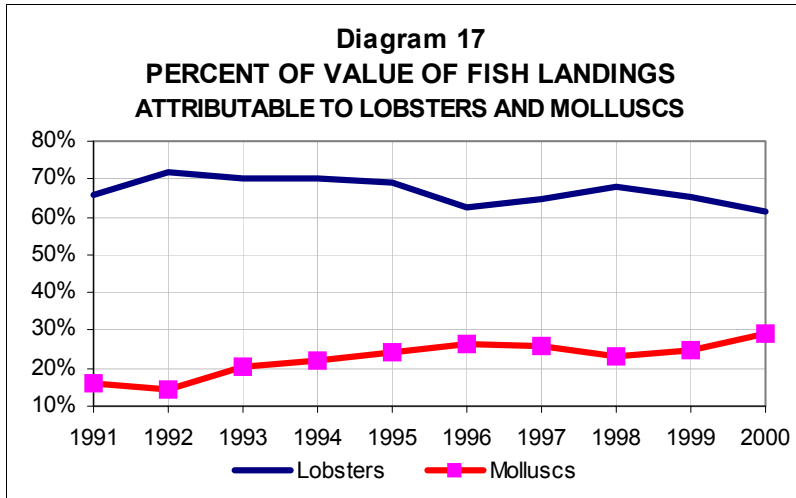

Diagram 16 shows that the Island hog industry has seen good and bad times during the last ten years. Although hog slaughtering was down 5 per cent over 1999, hog receipts in 2000 reached \$29.6 million, up 35 per cent over 1999, and only slightly below the all-time record of 1996.

## FISHERY

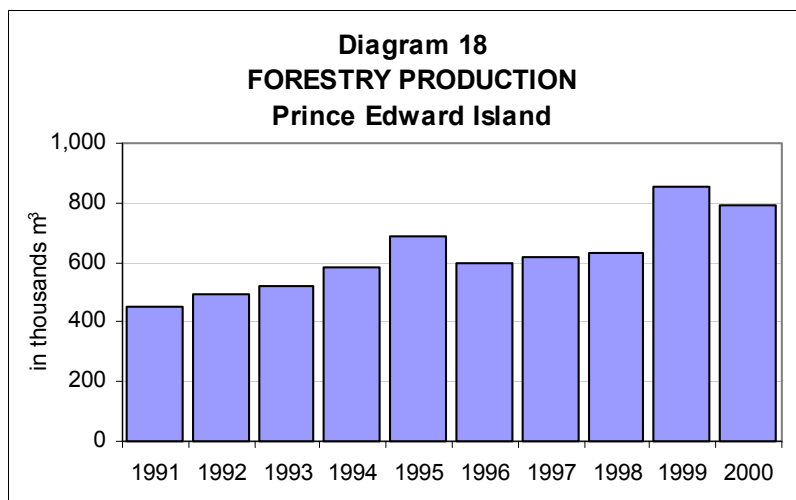
The total value of fish landings in 2000 was up by 5.4 per cent, from \$133 million in 1999 to \$139 million in 2000. The value of pelagic and estuarial catches was 9 per cent higher than in 1999, while the proceeds from molluscs and crustaceans other than lobster were up 19 per cent. Ground fish landings were 23 per cent lower than in 1999 with its value down by 34 per cent.

Even though the lobster catch in 2000 increased by 3 per cent to 19 million pounds, total revenue from lobster landings fell by 3.6 per cent, from \$88.9 million in 1999 to \$85.8 million in 2000. As shown in Diagram 17, due to an increasing share of molluscs in the value of total fish sales, the share of lobsters has been declining over the past ten years.

## FORESTRY



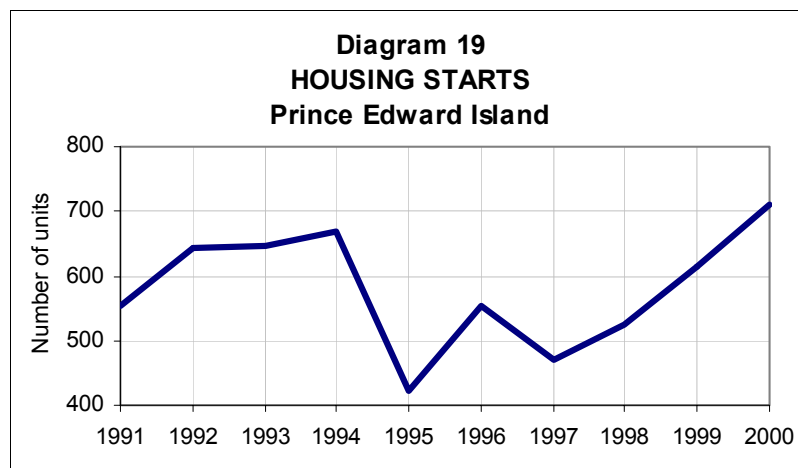

Diagram 18 shows that forestry production has increased substantially over the last ten years. During 2000 a major sawmill had reduced production to upgrade its facility. Consequently, the volume of primary forest products was down by 7 per cent, from 855 cubic metres in 1999 to 794 cubic metres in 2000.

Wood industry shipments were valued at \$55 million, down 10 per cent from 1999.

## CONSTRUCTION

According to Statistics Canada, total preliminary actual investment for Prince Edward Island amounted to \$534.3 million in 2000, up 3.3 per cent from 1999. This increase was principally the result of increased investment in the housing, retail, and primary sectors. Preliminary statistics indicate a drop in capital spending in public administration and manufacturing in 2000. Total private investments in 2000 were \$244.8 million in construction and \$191.6 million in machinery and equipment, while total public investments totalled \$74.5 million in construction and \$23.4 million in machinery and equipment.

As Diagram 19 shows, the upward trend in annual housing starts, which started in 1997, continued into 2000 with a 15 per cent increase over 1999. The number of dwellings under construction increased from 616 units in 1999 to 710 in 2000. This was the largest number of housing starts since 1990, when it reached 762

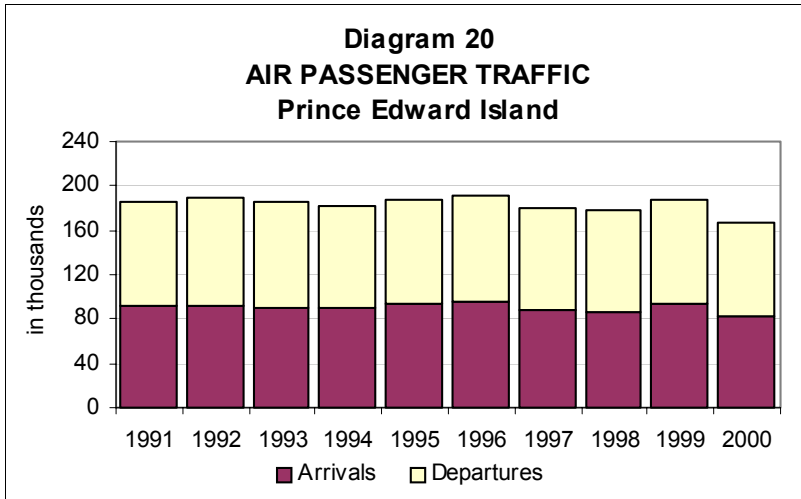
units.

## TRANSPORTATION

Prince Edward Island has several transportation links to the mainland: the Confederation Bridge; *Northumberland Ferries* between Wood Islands, P.E.I. and Caribou, N.S.; the *Marine Atlantic* ferry service from Souris, P.E.I. to the Magdalen Islands; the Charlottetown Airport; and the ports of Charlottetown, Summerside and Georgetown.

The principal source of travellers to the Island is the privately-owned Confederation Bridge. According to estimates provided by the P.E.I. Department of Transportation and Public Works, a total of 1.6 million vehicles crossed the Confederation Bridge in 2000, down 1.4 per cent from 1999.





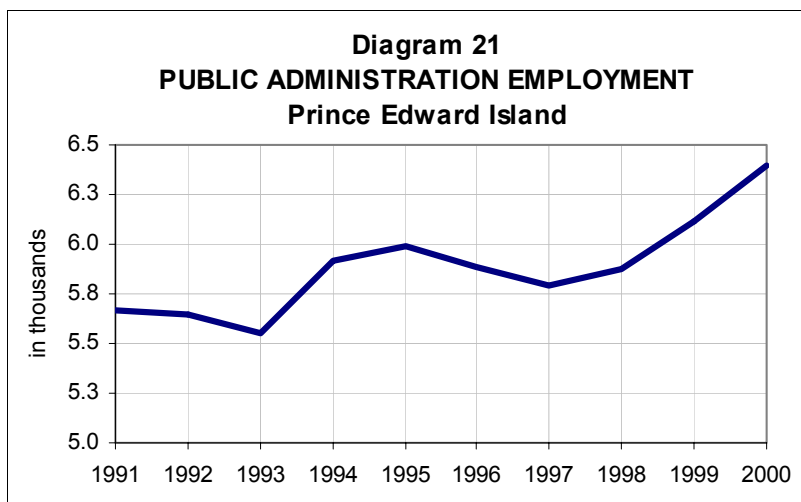

the *P.E.I. to Nova Scotia* ferry service was up by 4.2 per cent, while the number of vehicles ferried across was up by 5 per cent over 1999.

The number of passengers flying through the Charlottetown Airport in 2000 totalled 166,849, down 11 per cent from the previous year (see Diagram 20). Passenger traffic on the *P.E.I.-Magdalen Islands* ferry service increased by 4 per cent, while vehicle traffic was up by 3.4 per cent in 2000. The number of passengers taking

## THE SERVICE SECTOR

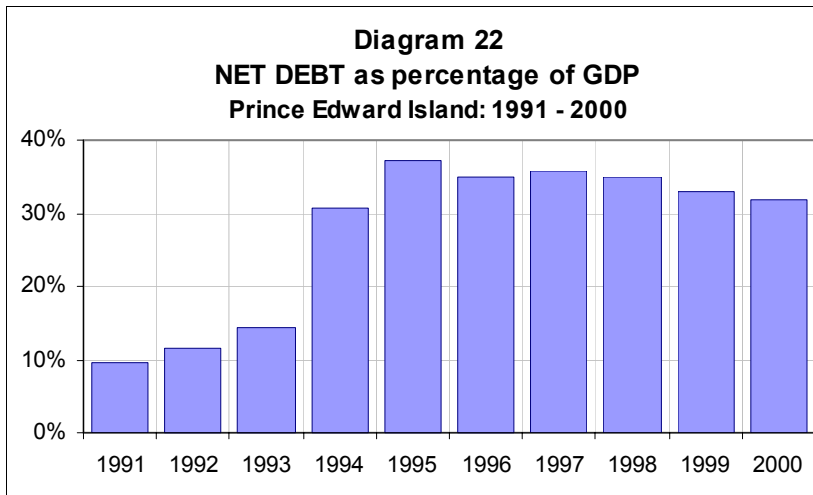
While employment gains in the goods-producing sector amounted to 10 per cent between 1991 and 2000, job growth in the services-producing sector totalled 25 per cent. According to Statistics Canada's *Labour Force Survey*, growth was led by health and social services (up 36 per cent), followed by retail trade (up 31 per cent), education (up 27 per cent), and accommodation and food services (up 25 per cent). The service sector made up 75 per cent of provincial GDP at factor cost in 1999.

Diagram 21 portrays employment levels in public administration. As can be seen, in 2000 employment in the public administration sector continued its climb that started in 1997. Public administration, together with education, health and social services, accounted for 35 per cent of total Island employment in 2000.

## PROVINCIAL FINANCES

1999/00 was \$5.4 million, compared to a surplus of \$6.3 million in 1998/99. As of 31 March, 2000, the net debt was \$1,024.3 million, up 3.4 per cent from 1999. Diagram 22 illustrates the decline in the Net Debt-to-GDP ratio since 1991.

In the fiscal year ending 31 March, 2000, the total revenue received for the province of Prince Edward Island was \$900.4 million, up 5.7 per cent from 1999. Total expenditures increased by 5.6 per cent to reach \$899.3 million. After pension adjustment and allowances for reclassified loan and capital lease, the deficit for

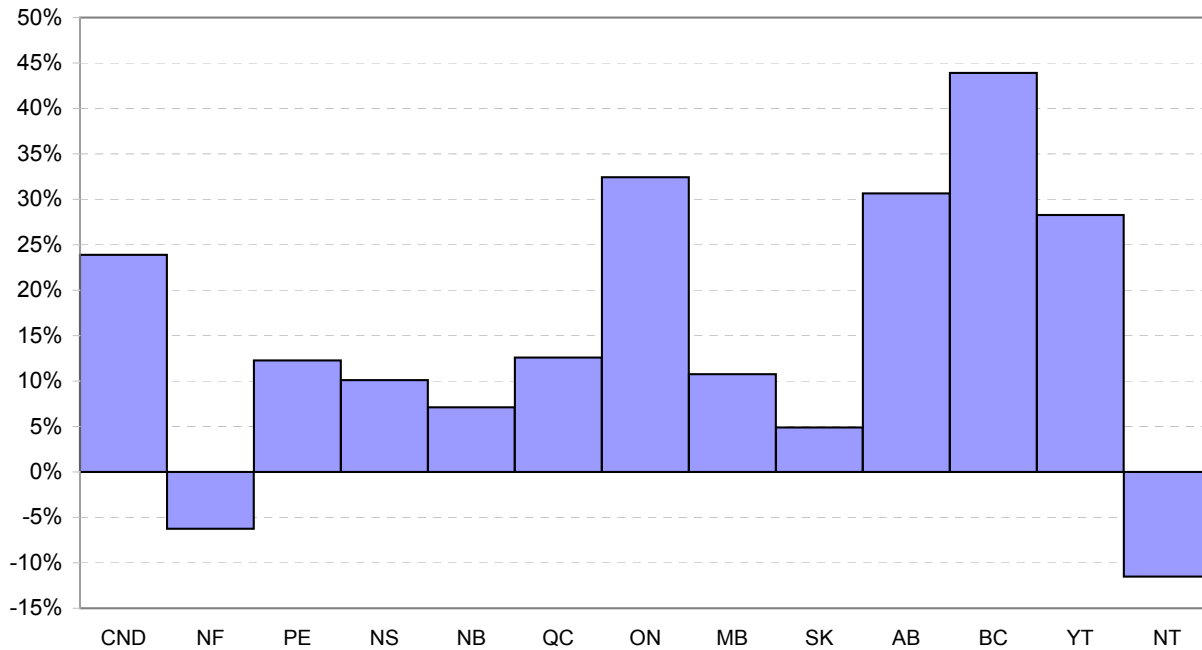

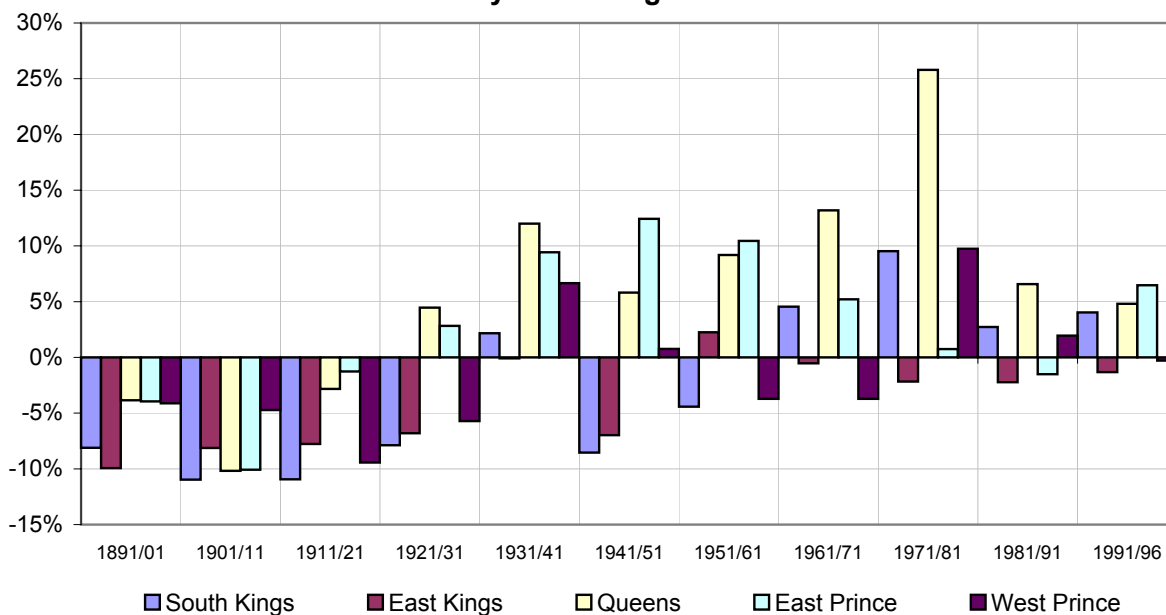

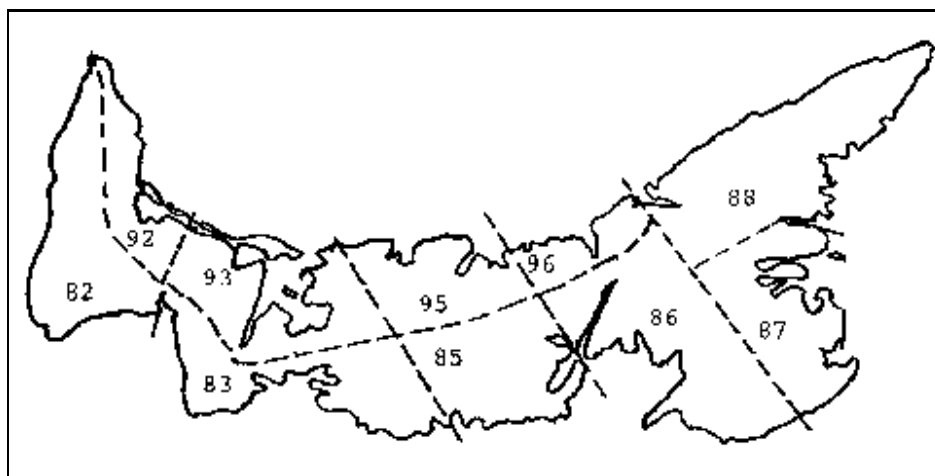
